

Spectracom, a business of The Orolia Group, offers this End-User License Agreement (EULA) for StudioView Software. PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE INSTALLING THE SOFTWARE. Spectracom's EULA is a legal agreement between you the Licensee (either an individual or a single entity) and Spectracom and its affiliates ("Spectracom") for StudioView software product, which may include associated software, components, media, printed materials, and online or electronic documentation ("SOFTWARE PRODUCT").

By installing, copying or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

This SOFTWARE PRODUCT is licensed, not sold.

NUMBER OF ALLOWABLE INSTALLATIONS

Single Use License: If you have a single user (single seat) license, you are authorized to install this software on ONE (1) computer only. You will need to obtain additional licenses from Spectracom or its affiliate if you wish to install this software on more than one computer.

Site, 10-License: If you have a 10-seat Site License, you may load this software onto a maximum of ten (10) computers at one site. A site is a single, contiguous physical location controlled by a single organization, for example, a single postal address.

Enterprise, 5-License: If you have a 5-seat enterprise license, you may load this software onto a maximum of five (5) computers within an organization or enterprise, without regard to physical location.

Enterprise, 10-License: If you have a 10-seat enterprise license, you may load this software onto a maximum of ten (10) computers within an organization or enterprise, without regard to physical location.

Unlimited, Site License: If you have a site license with unlimited seats, you may load this software onto an unlimited number of computers at one site. A site is a single, contiguous physical location controlled by a single organization, for example, a single postal address.

INSTALLATION AND USAGE

Spectracom grants you the right to install and use StudioView on the number of computers for which you have purchased licenses in order to acquire data from a GSG-5x series GPS/GNSS Signal Generator produced by Spectracom. You may not translate, modify, adapt, reverse engineer, disassemble, decompile, or in any other way use the software in part or in whole for other work than for what it is intended. You may not sell, sub-license, rent, or lease the program or any portion thereof.



Unauthorized copying of the SOFTWARE PRODUCT or failure to comply with the above restrictions will result in automatic termination of this Agreement and will constitute immediate, irreparable harm to Spectracom for which monetary damages would be an inadequate remedy, in which case injunctive relief will be an appropriate remedy for such breach.

BACKUP

You may make one copy of the installation files for backup and archive purposes.

TRANSFER

You may not transfer the software and license to another person. You may not rent, lease, lend sublicense, assign or transfer the license or SOFTWARE PRODUCT.

SUPPORT SERVICES

Spectracom may provide you with support services related to the SOFTWARE PRODUCT. Any supplemental software code provided to you as part of these services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA.

VALIDITY

This EULA is in effect unless terminated or rejected. This EULA will be terminated if you fail to comply with any of its terms and conditions. Upon termination of the EULA, all copies of the software must be destroyed.

PROPRIETARY RIGHTS

All intellectual property rights in the SOFTWARE PRODUCT and user documentation are owned by Spectracom and are protected by law, including but not limited to United States copyright, trade secret, and trademark law, as well as other applicable laws and international treaty provisions. The structure, organization and code of the SOFTWARE PRODUCT are the valuable trade secrets and confidential information of Spectracom. You shall not remove any product identification, copyright notices or proprietary restrictions from the SOFTWARE PRODUCT.

CONSENT TO USE OF DATA

You agree that Spectracom may collect and use technical information you provide in relation to support services related to the SOFTWARE PRODUCT. Spectracom agrees not to use this information in a form that personally identifies you except to the extent necessary to provide such services.

WARRANTY

The seller guarantees that the installation media are free from physical defects, and that the reproduction of the software is complete. This guarantee is valid for 90 (ninety) days from the date of delivery. If the software package fails to fulfill this guarantee, you will receive another installation software package or will be able to download installation files from Spectracom web resources containing the same software, free of charge, when you return the faulty software package with a description of the fault.



The above limited guarantee is the only guarantee given and it replaces any other expressed, implied, statutory or other warranty.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, SPECTRACOM AND ITS SUPPLIERS PROVIDE THE SOFTWARE PRODUCT "AS IS" AND WITH ALL FAULTS, AND HEREBY DISCLAIM ALL OTHER WARRANTIES AND CONDITIONS, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF TITLE AND NON-INFRINGEMENT, ANY IMPLIED WARRANTIES, DUTIES OR CONDITIONS OF MERCHANTABILITY, OF FITNESS FOR A PARTICULAR PURPOSE, AND OF LACK OF VIRUSES ALL WITH REGARD TO THE SOFTWARE PRODUCT. extent the terms of any Spectracom policies or programs for support services conflict with the terms of this EULA, the terms of this EULA shall control. In the event of a conflict between the English and any non-English versions of this EULA, the English version shall govern. If any provision of this EULA is held by a court of competent jurisdiction to be contrary to law, such provision will be changed and interpreted so as to best accomplish the objectives of the original provision to the fullest extent allowed by law and the remaining provision of the EULA will remain in force and effect.
